TERMS AND CONDITIONS

No resale or offer to resell this Ticket is permitted to the extent prohibited by any applicable federal, state or local law or regulation.

Any violation of the terms and conditions shall give Licensor the right to revoke the License immediately without having to refund the established price. Licensor reserves the right to refuse admission or eject any person who violates Licensor's policies. All persons seeking entry into the Stadium specifically consent to and are subject to metal detector and physical pat-down inspections prior to entry. All bags may be thoroughly inspected. Any person or object that could affect the safety of the Stadium, its occupants or its property shall be denied entry. By using this Ticket, each of Licensee or bearer of this Ticket, agrees that: (i): he/she shall not transmit or aid in transmitting any information about the Event, including, but not limited to, any account, description, picture, video, audio, reproduction or other information concerning the Event (collectively, "Event Information"); (ii) Licensor is the exclusive owner of all copyrights and other proprietary rights in the Event and Event Information; and (iii) Licensor and its lawful agents, successors and assigns shall have the unrestricted right and license to use Licensee's image, likeness, name, voice, comments or other proprietary or public rights and that of any minor accompanying Licensee, in any broadcast, telecast, photograph, video, audio sound, audiovisual and/or other recording taken of, or made in connection with, the Event or other transmission or reproduction, in whole or in part, of the Event, for all purposes, worldwide, in perpetuity and in any and all means and media now or hereafter known, without compensation. The rights granted herein to Licensor are assignable.

The bearer assumes all risk and danger incidental to the Event, including the sport of baseball and all warm-ups, practices and competitions associated with baseball, including the danger of being injured by thrown bats, fragments thereof, and thrown or batted balls, and agrees that Licensor, Ticketmaster, L.L.C., the State and City of New York, Major League Soccer and each of its clubs and affiliates, MLB and each of its clubs and affiliates and each of the foregoing entities respective agencies, departments, subdivisions and each of their officials, directors, agents, players, officers, employees and owners shall not be liable for any personal injury or property loss/damage.
