Adult Signature Required

Please send your wine to a home or business address where an individual at least 21 years of age is available during regular business hours to sign. By law all alcohol orders require an adult signature for delivery. UPS or Fedex will make up to 3 delivery attempts.

Ground Shipping

Depending upon your state, delivery is 3-14 business days. All custom labeled wine orders are hand-labeled and typically take up to two to three business days to process.

States Where Wine Can Not be Delivered
